### 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

**Inhalation:** Supply fresh air. If required, provide artificial respiration. Keep patient warm. Consult doctor if symptoms persist.  
In case of unconsciousness place patient stably in side position for transportation.

**Skin Contact:** If skin or hair contact occurs, immediately flush body and clothes with large amounts of water, using safety shower if available. Quickly remove all contaminated clothing, including footwear. Wash skin and hair with running water. Continue flushing with water until advised to stop by the Poisons Information Centre. Transport to hospital, or doctor.

**Eye Contact:** If this product comes in contact with the eyes: Immediately hold eyelids apart and flush the eye continuously with running water. Ensure complete irrigation of the eye by keeping eyelids apart and away from eye and moving the eyelids by occasionally lifting the upper and lower lids. Continue flushing until advised to stop by the Poisons Information Centre or a doctor, or for at least 15 minutes. Transport to hospital or doctor without delay. Removal of contact lenses after an eye injury should only be undertaken by skilled personnel.

**Ingestion:** If swallowed in large quantities seek medical attention.

### 6. ACCIDENTAL RELEASE MEASURES

Minor Spills:	Environmental hazard – contain spillage. Clean up all spills immediately. Avoid breathing vapours and contact with skin and eyes. Control personal contact with the substance, by using protective equipment. Contain and absorb spill with sand, earth, inert material, or vermiculite. Wipe up. Place in a suitable, labelled container for waste disposal. Drains for storage or use areas should have retention basins for pH adjustments and dilution of spills before discharge or disposal of material. Check regularly for spills and leaks.
Large Spills:	Environmental hazard – contain spillage. <ul style="list-style-type: none"><li>• Clear area of personnel and move upwind.</li><li>• Alert Fire Brigade and tell them location and nature of hazard. Wear breathing apparatus plus protective gloves</li><li>• Prevent, by any means available, spillage from entering drains or water course. Stop leak if safe to do so.</li><li>• Contain spill with sand, earth, or vermiculite.</li><li>• Collect recoverable product into labelled containers for recycling. Neutralise/decontaminate residue (see Section 13 for specific agent). Collect solid residues and seal in labelled drums for disposal.</li><li>• Wash area and prevent runoff into drains.</li><li>• After clean-up operations, decontaminate and launder all protective clothing and equipment before storing and re-using. If contamination of drains or waterways occurs, advise emergency services</li><li>• Mount respiratory protective device.</li><li>• Wear protective equipment. Keep unprotected persons away</li></ul>

### 7. HANDLING AND STORAGE

**Handling:**

Avoid all personal contact, including inhalation.
